SELECTMEN

MEETING MINUTES AUGUST 22, 2016

The meeting was called to order at 7:00 P.M. Present were Jay Croteau, Bruce Smith and Eric Eichner. Monday August 29, 2016 will be a short work night for the selectmen.

The selectmen reviewed the Labor law posters and marked the employment wages to be paid by Friday in accordance to the town's policy.

The selectmen were invited to the Fire Station next Monday August 29, 2016 to watch an equipment demonstration.

The selectmen discussed having Peter Morin complete the current use application to add the river frontage in question to his current use lot. The selectmen felt it was the best solution for the frontage. Signatures from the Morin's are needed before September 1, 2016.

Durwin Clark took care of seeding the Nadeau lot in the cemetery and the roadside along the Larocca's embankment.

Jay Croteau has sold the radar unit to the Walpole Police for \$500.00. The unit is very old but is still useful however the other unit does not function. He will write a Bill of Sale for the unit.

Eric Eichner motioned to accept the minutes. Bruce Smith seconded the motion. The selectmen agreed to accept the minutes.

The last bill from the Community Kitchen has placed the budget over by \$1000.00.

Josh Brooks dropped off a bill of \$ 1490.00 from Stripe It Seal It for the sealing job. He also spoke with the selectmen about using Knox boxes on the public buildings for the fire department. The boxes cost about \$115.00 apiece and would be building specific. There are several private installations of the boxes currently at use in the community.

Bruce Smith has spoken to Liberty utilities about the trees at the top the Joslin Road. The remaining trees will be scheduled to be cut down sometime in November. Bruce Smith will contact the owner.

Jay Croteau has spoken with Durwin Clark about the undermined culvert on the Pond Road.

Bruce Smith inspected the Webster Road and stated it was passable by car. Jay Croteau will speak with Durwin Clark about raking the road.

The selectmen discussed the need for some guardrails at the new Pond Road culvert. The wetlands bureau needs to be notified about the completion of the project.

Bruce Smith reviewed the listings of appointments in the town report and the Survey or timber appointments are no longer needed. He went over the library trustees and the appointment of a representative for the town and the appointment of the librarian. Jay Croteau will talk to Darlene Clark about the forms needed from the trustees.

Bruce Smith will attend the NHMA meeting Friday 23, 2016.

Jill Lane will look at new copiers at Staples.

The selectmen will pay bills next week.

Eric Eichner motioned to adjourn. Jay Croteau seconded the motion. The selectmen agreed to adjourn.
