N. Chapkovich – Asked if this was a realistic amount to cover the SAU services the district needs, given how much Surry has paid in the past. M. Gross – Surry does not use a great deal of SAU 38 services. They give expert advice, special education, bookkeeping, etc. Townspeople often volunteer their energies to fulfill tasks that the SAU would otherwise complete. For this amount of money, the Board feels that it can contract out for specific Superintendent services that we need. It might hire someone part-time or coordinate with another SAU to share services.
