MEETING MINUTES APRIL 23, 2018

The meeting was called to order at 7:00 P.M. Present were Bruce Smith and Eric Eichner. Jay Croteau was absent.

Ben Hoy spoke with the selectmen about various local routes the Surry Village Charter School Running team could possibly use to avoid running on Route 12 A. He was referred to Joe Quintillio and John Assenge of the Army Corp of Engineers.

Bruce Smith motioned to accept the minutes. Eric Eichner seconded the motion. The selectmen accepted the minutes.

The selectmen signed the payroll.

The selectmen signed the State of NH DOS- DMV for April 19, 2018 and April 23, 2018.

The selectmen received a bid from BDM for paving the Joslin Rd. The selectmen spent time comparing the two bids and noted there was a difference in two for basecoats and top coats.

The selectmen received Wally Reney's Auditors report on April 16, 2018 .

The selectmen discussed the information from Carolyn Berglund regarding the tax liens.

The selectmen discussed the adding the adjacent town lot owned by the town to the Bardwell lot if he was interested.

The Dept. of Labor has issued a certificate of inspection for the fire department.

Bruce Smith will be attending a meeting with DES for a presentation of the plan for the lower section of the Pond Rd. The selectmen will continue to work with Jonathan Sisson to complete the project with the current engineer. The selectmen will also explore the costs of the do nothing option.

The selectmen agreed to add two new culverts to the list for the Pond Rd recommended by Durwin Clark and David Brooks. Bruce Smith will confirm with Jonathan Sisson about completing the DES applications needed.

Bruce Smith reported the Highway Budget looks within bounds for the first quarter . The selectmen looked at the budget going into the second quarter.

Bruce Smith stated there would be a \$1400.00 difference in the revaluation budget due to Avitar's December monthly billing for the 2017 revaluation work which was paid in January 2018.

The selectmen discussed moving the fax line out of the selectmen's office to the main room.

Fred Bretton will revisit Helen Smith's site when he returns to Surry to measure and set the names and addresses.

The selectmen agreed to transfer the funds to the Trustees of Trust Funds next week for the town building expendable trust.
