MEETING MINUTES MAY 6, 2024

The meeting was called to order at 7:00 P.M. Present were Jay Croteau, Steve Goldsmith and Ron Profaizer.

Copy of trust requested for Plaskiewicz to complete paperwork.

The selectmen signed Profaizer exemption . Copies of trusts on file..

Zane White was given an Intent to Excavate application. Permit to operate comes from Planning Board.

Steve Goldsmith signed off on Woody Streeter building on Webster Road as completed.

The selectmen signed and paid bills.

The selectmen signed payroll.

The selectmen signed the EFTPS payment.

John Davis spoke with the selectmen regarding Dave Brooks driveway culvert. Discussed who would be maintaining the culvert. Went over septic parameters of 100 Ft from Town and state parameters of 75ft. The Conservation Committee signed the driveway permit.

Mark Gross spoke with the selectmen about submission of application for current use changes for two lots. A completed matrix for returning the two lots to Current use with separate applications for each lot is needed. Jay Croteau suggested a lot line adjustment for the property

The Town of Surry received \$5,684.79 for the Highway Block payment.
