MEETING MINUTES JUNE 10, 2024

The meeting was called to order at 7:00 P.M. Present were Steve Goldsmith and Ron Profaizer. Jay Croteau was absent.

Building inspector Steve Goldsmith signed off on *plumbing*, insulation and electrical for 12 Mason Drive Justin Baker home.

Building permit check due from Bob Bergervin. Also, \$200.00 for sale of cemetery mower.

MS 60 W Audit Waiver was voided for exceeding the 750 population limit according to the 2020 Census. A MS 60 A should be used with an auditor.

Karyn Hagen inquired by email for authorization to purchase a laptop and compatible printer for Supervisors of the checklist for the 2024 election cycle.

Ron Profaizer motioned to permit Karyn Hagen to purchase a laptop and if needed a printer compatible with the State of NH for Supervisors of the checklist for the upcoming 2024 election cycle. Steve Goldsmith seconded the motion. The selectmen agreed.

Ron Profaizer toured Surry's roads with Durwin Clark. He photographed the culvert south of the Pond Road and noted Durwin Clark stated the culvert in question was the homeowner's responsibility. They discussed mowing the roadsides, purchase of a one ton truck with a plow and sander for the smaller roads, and mileage compensation for personal use of his vehicle for town business. Ron Profaizer stated he had not seen a response from Bradley Law Firm on the Cider Mill questions.

Ron Profaizer updated officials on the town page of the website.
