MEETING MINUTES JUNE 24, 2024

The meeting was called to order at 7:00 P.M. Present were Jay Croteau, Steve Goldsmith and Ron Profaizer.

Steve Goldsmith confirmed the set back on website is correct at 50 ft. to builder Kyle Harper on 43 Farm Rd.

Building permit #1676 for Chris Pelletier for new roof addition.

Worked with Andy Felegara for tax maps and abutters in preparation for New England Canine Search and Rescue for a training event July 20, 2024 9:30 – 1:30.

The Town of Surry received ck#113 in the amount of \$25.00 for building permit #1677 issued to Surry Mountain Campground / Melanie and Dan Lucuis for Amer Electric and Eversource to upgrade the electrical at the campground.
