We are in Keene's AREA which gives us a discount on tuition in exchange for a 20-year agreement. We have learned to address special needs in the preschool years.

We don't have employees, Kim, Julie and Nathan are contractors.

The Surry School District is separate from the Town of Surry and separate from the Surry Village Charter School.

We give back any leftover funds at the end of the year to lower the following year's tax rate.

We found re-starting the Surry School was too expensive, it would cost as much as sending K-12 to Keene.

The School Board's job it to oversee the business end of providing an education to Surry children.

We did get \$3600 NH grant for extraordinary needs this year, (based on free & reduce lunch numbers), unlikely to get it next year
