MEETING MINUTES DECEMBER 16, 2024

The selectmen agreed to have the Fire Department issue the ID for John Davis as Health Officer.

Sabrina Contrady submitted her hours for the elections. Submitted payment request for ID for John Davis.

Locking file fire proof cabinet for elections requested by Denise Dragon is approximately \$2500 to be added to the Town Clerk budget request.

Tree Agents LLC has filed for an appeal to the ZBA for Joslin Road subdivision.

Corery Rice cannot be listed as a Surry business because his business is located in Swanzey, NH.

Community Power meeting is scheduled for 1/27/2025 at 6:00 at the Town Hall.
