SELECTMEN

MEETING MINUTES JUNE 16, 2025

The meeting was called to order at 7:00 P.M. Present were Ron Profaizer and Steve Goldsmith. Jay Croteau was absent.

Jaff Cushing received an application for a driveway permit for 10 Cider Mill Road owned by Sarah Cushing. Steve Goldsmith explained the process for the permit, culvert placement and plot plan recommendations. He was referred to the Planning Board.

Bruce Smith researched the town's warrant articles and found no evidence regarding the establishment of fees per RSA 41:9-A.

Ron Profaizer motioned to accept the minutes for 6/9/2025. Steve Goldsmith seconded the motion. The selectmen agreed to accept the minutes as presented.

The selectmen signed payroll.

The selectmen signed and paid bills.

Steve Goldsmith motioned to cease upkeep on the Holland Tractor. Ron Profaizer seconded the motion. The selectmen agreed.

Ron Profaizer is working on establishing a credit account with WB Mason for office supplies with separate accounts for selectmen, town clerk, treasurer and tax collector.

The website has been updated with the notifications for July 10th hard stop for dog licensing with information confirmed by the town clerk this afternoon.

Ron Profaizer drafted regarding failure to license dogs with information for delinquent dog owners. Authorization for next year to town clerk to impose fees. Carry over to next week.

Complaints of dog fights on Army Corp of Engineers land. Reminders of leash law in town.

Steve Goldsmith and Ron Profaizer attended effective code enforcement seminar. Discussed take aways for junkyard permits, junkyard ordinances and enforcement by state law.

Bruce Smith commented the town was allowed to enforce the state law.

Ron Profziaer dropped off water sample testing to the NH Health and Human Services in Concord. Results in approximately three weeks.

Jay Croteau completed the application for credit cards with TDbank. Draft copy of credit card policy.
