MEETING MINUTES NOVEMBER 24, 2025

The meeting was called to order at 7:05 P.M. Present were Jay Croteau, Steve Goldsmith and Ron Profaizer.

selectmen signed and paid bills.

Jay Croteau presented draft letter for Anderson. Municipal attorney stated a conditional zoning variance would need to be completed with deficiencies corrected and five criteria met.

Bruce Smith agreed to putting Health Officer expense under Executive for now.

Jay Croteau completed and signed HGAC contract for Fire Department to submit specifications for brush truck.

Ron Profaizer has poste GM2 Assessment for bridge.

Jay Croteau has not received a response to the Health letter. Cottage

Durwin Clark will be asked to move-the speed sign to Joslin Rd. for data collection. The selectmen will a lso inquire about the salt usage for the town.

The selectmen entered into the discussion about the building fees for the town raising the minimum fee to \$60.00 for pools, electrical, mini splits, solar arrays and sheds and an increase to \$.20 per square foot for houses. The building permit cost for an average 2000 square foot house would be \$400.00. An application fee for a demolition permit and a driveway permit would be \$60 minimum. There is also a \$.30 per square foot fee for commercial buildings.
