SELECTMEN

MEETING MINUTES DECEMBER 15, 2025

The meeting was called to order at 7:00 P.M. Present were Jay Croteau, Steve Goldsmith and Ron Profaizer.

The selectmen signed and paid bills.

The selectmen signed payroll.

Jay Croteau motioned to accept the minutes as presented. Ron Profaizer seconded the motion. The selectmen agreed to accept the minutes.

Steve Goldsmith has ordered the materials for the hot water heater for the Highway garage.

Jay Croteau reported the Anderson letter had been delivered.

The Town of Surry received Current Use application from Dean Dorman 105 Farm Rd to remove 1.97 acres for building lot. Luct pending upon removal. Existing structures to be removed. Owners intend to post the property triggering removal of the recreational discount for CU. The Town of Curry received ck# 878 in the amount of \$24.00 from Dean Dorman made out to the Registry of Deeds for recording.

Ron Profaizer received an email from John Davis requesting \$500.00 for budget for Health Officer. NH Membership for Nh Health Officers Association invoice for 2026 of \$50.00.

Steve Goldsmith has requested annual budget meeting early in January from Budget Committee.

Planning Board meeting possibly on January 14, 2026.

Confirmed January 7th 2026 meeting for warrant article fee schedule 7:00P.M. at the townhall.

Bruce Smith has requested budgets in by January 5, 2026.

Steve Goldsmith inspected framing, rough wiring, and rough plumbing for Roe on 180 Farm Rd. No additional permit needed for Broadvest for mechanical.

Josh Brooks reviewed the request for purchasing the brush truck with the \$300,000.000 grant. through Skeeter out of Texas. With a modular body the price came down from the original quote of \$400, 000.00 to approximately \$360,000.00 with the balance from the capital reserve fund. The match would still need to be made of 5% of the total cost with payment upon delivery. Build process would take approximately 24 months and they would like to start the

process. AFG grant to town for reimbursement after town payment. Discussion of selling old brush truck which cannot be sold to another fire department.

Steve Goldsmith reported no answer to Williams letter.

Jay Croteau will respond to questions confirming cottage industry. May need a Variance.

Luisignau emailed tax car for Boudreau.

No concerns for DOT driveway application for Lakeview(J. Cheney) No need to respond.

General protocol for warrant requirements. Ron Profaizer brought up the need for Legal services for warrant articles.

The selectmen discussed logging the Town Forests. They will ask John Davis about history of logging.

City of Keene Hazardous Waste agreement signed. Jay Croteau motioned to send the contract. Ron Profaizer seconded the motion. The selectmen agreed to sign and return the contract.

Ron Profaizer motioned to adjourn. Steve Goldsmith seconded the motion. The selectmen agreed to adjourn.
